### A) How to become a member?

- ✓ Apply with all relevant documents to the Executive Committee of the Indian Business Council for the approval.

### B) Minimum criteria for becoming a member:

#### A representative

I. Must be an Indian Passport holder with a Valid DIRE,

Or

II. Must be a Mozambican passport holder with a Valid OCI/PIO card,

Or

III. Must be a resident of Mozambique with valid proof of Indian origin

- Accepted documents/details for proof of Indian origin
  - Place of birth in India,
  - Documents/reference details of grandparents,
  - Documents/reference details of spouse, children, uncle, and in-laws,
  - Testify the identity of Indian origin by two existing IBC members,
- Special note for the proof of Indian origin:
  - All docs, reference details must prove that you are descended from India.
  - Membership will be considered if all details are true, and presented documents are issued in the Indian Territory.

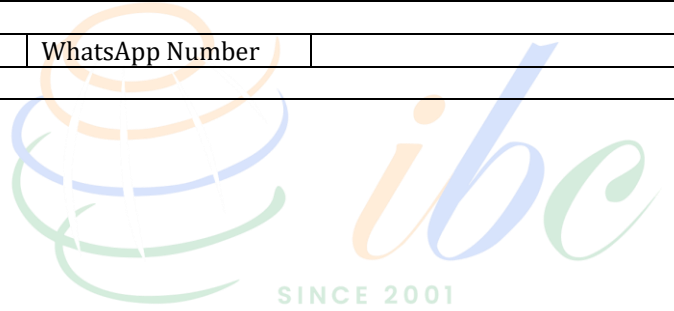
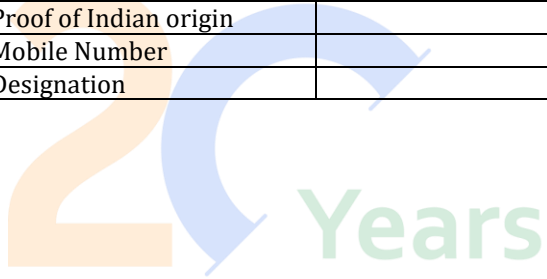
